3. (A) RECEIPT OF PUBLIC TESTIMONY ON PROPOSED CHANGES TO SECTION 632, TITLE 14, CCR, RE: MARINE PROTECTED AREAS IN THE CALIFORNIA SOUTH COAST STUDY REGION PURSUANT TO THE MARINE LIFE PROTECTION ACT. (Note: The adoption hearing is scheduled for December 15, 2010 in Santa Barbara.)
Received the Department's review and update from Becky Ota and Susan Ashcraft. Received public testimony from approximately 146 persons. No action taken by the Commission.
