2. (A) PURSUANT TO SECTION 2074.2 OF THE FISH AND GAME CODE, CONSIDERATION OF THE DEPARTMENT'S INITIAL REVIEW AND RECOMMENDATION, AND POSSIBLE ACTION ON THE PETITION TO LIST THE CEDARS WILD BUCKWHEAT (*Eriogonum cedrorum*) AS ENDANGERED UNDER THE CALIFORNIA ENDANGERED SPECIES ACT.  
**Acting Executive Director Fischer summarized the item. Received the Department's review and recommendation from Jeff Brandt and Cherylyn Burton via Skype, that the petition did not contain sufficient information to indicate that listing may be warranted. No public testimony.**

RECEIPT OF DEPARTMENT RECOMMENDATION CONCERNING THE ISSUANCE OF INCIDENTAL TAKE PERMITS PURSUANT TO SECTION 2080 OF THE FISH AND GAME CODE.

**Acting Executive Director introduced the item. Deputy Executive Director Shea reported that there would be a completed staff recommendation, and options/range of alternatives provided to the Commission and published on the Commission's website by the end of May. Received public testimony.**

(A) DISCUSSION AND POSSIBLE COMMISSION ACTION ON MARCH 31, 2011, LETTER FROM CENTER FOR BIOLOGICAL DIVERSITY (PETITIONER) REGARDING THE PETITION TO LIST THE AMERICAN PIKA (*Ochotona princeps*) UNDER THE CALIFORNIA ENDANGERED SPECIES ACT. **Acting Executive Director Fischer summarized the item. Deputy Attorney General Thalhammer provided his legal review and recommendations to treat the information as an amended petition and return it to DFG for its review and evaluation. No public testimony.**
